#### **Introductions and Welcome**

Andy Turner called the meeting to order at 1538h and it was determined there was a quorum. Andy acknowledged the current committee chairs and the past presidents and officers of MOAFS, the North Central Division (NCD), and the American Fisheries Society (AFS).

Andy updated membership on various activities MOAFS was involved in throughout the past year.

- The membership appreciation day was held on September 14<sup>th</sup> and consisted of a float trip on the Eleven Point River followed by a potluck dinner. Andy encouraged all members to attend the membership appreciation day this upcoming year.
- MOAFS made money contributions to a variety of causes this year including: Catfish 2020: 3<sup>rd</sup> International Catfish Symposium, AFS Hutton Program, AFS Socioeconomic Section: Weithman Award, and to the Missouri Stream Team Watershed Coalition.
- MOAFS has continued to work with the Conservation Federation of Missouri (CFM).
   MOAFS served as a representative at the affiliate summit, supported affiliates in
   opposing changes to Missouri Department of Natural Resources (MoDNR) listing
   methodology of the Section 303(d) list, and provided a nominee and voted for CFM
   affiliate board members. MOAFS was also featured in the March issue of the CFM
   magazine as the affiliate spotlight.

#### Guest Speaker: Jeff Kopaska

Andy Turner introduced Mr. Kopaska who is the NCD president and works at the Iowa DNR as a biometrician. Jeff provided membership with an update on the NCD and the parent society. AFS President, Scott Bonar and AFS Executive Director, Doug Austen, were both in attendance at the 150 year celebration of AFS in Columbus, Ohio. At the 150 year celebration, Scott spoke about the importance of communicating science to climate change. Jeff also reported that AFS has been very active in opposing the new Waters of the U.S. (WOTUS) ruling.

Jeff also shared several highlights from the NCD business meeting.

- A technical committee has been created to focus on increasing urban fishing in public waterbodies.
- The creation of 'Hero of Fisheries' stickers. These fish stickers were distributed to fisheries professionals as a small token of appreciation from one professional to another.
- MOAFS won an award presented by NCD for best communication. The award acknowledges the MOAFS bi-annual newsletter, *The Redd*. Jeff presented the award to Andy Turner.

Lastly, Jeff presented a statewide angler survey conducted in Iowa. The survey is conducted every 10 years and asks a variety of questions regarding overall angler satisfaction.

#### **Anglers with Disabilities Committee**

Mary Scott reported the committee will host two events this upcoming year. The first will be at Meramec Spring Park on April 10th, with the second being held at the Rolla Lions Club Park on September 19th.

Mary was also pleased to announce, the committee applied for and received the David Risberg Memorial Affiliate Grant through CFM. The grant has a value of \$500.00 and will help fund the cost of t-shirts for the two events being held this year.

#### **History Committee**

There were no updates to report at this time.

#### **Continuing Education Committee**

Andy Turner provided an update for Brad Farwell. The committee participated in the Missouri Natural Resources Conference (MNRC) job fair, approximately 120 students attended. The NCD AFS continuing education committee presented the knowledge seeker award at the Midwest Fish and Wildlife Conference. Brad has also been working on the 2020 SEAFWA meeting, which will be held in Springfield, MO.

#### **Information Technology Committee**

There were no updates to report at this time.

#### **Legislative and Environmental Concerns Committee**

Emily Tracy-Smith reported that over 1700 bills have been introduced throughout this legislative session. The committee is monitoring multiple bills that could have a negative impact on Missouri's natural resources. Emily encourages all membership to utilize several resources available to stay up to date on advocacy issues. Stream Teams United (STU) has a newly updated website which posts information about relevant environmental issues at the local, state, and national level. Users can also subscribe to the STU email list to receive updates. Emily also urged membership to sign up for the CFM Legislative Action Center. The action center is an easy way to stay informed on legislative issues and provides users with the ability to submit comments to local representatives regarding proposed bills.

#### **Newsletter Committee**

Emily Tracy-Smith recognized Dan Metcalf for his awesome creativity with the newsletter. Emily also asked membership to submit photos and descriptions of MOAFS activities to be included in the newsletter. If you have any questions, contact any of the committee members.

#### **Membership Committee**

John Lisek reported that the revamped membership tracking method is working well.

#### **MNRC Steering Committee**

Blake Stephens reported 700-750 people registered for MNRC and 733 room nights were booked. Lastly, Blake mentioned MOAFS will host the 2022 MNRC meeting. If you have any positive or negative comments about this year's conference or suggestions for 2022, please contact Blake or another steering committee chair.

#### **Publicity Committee**

Eric Rahm provided an update for Trish Yasger. Eric thanked all those who worked in the MOAFS booth, and those who donated auction items. The outdoor auction raised \$1145.00, and the other auction items yielded \$325.00.

#### **Rivers and Streams Committee**

Tom Boersig announced there will be a short meeting after the conclusion of the annual meeting.

#### Treasurer's Report

Darby Niswonger announced that 2019 was a great financial year for MOAFS and the Student Support Trust Fund (SSTF). The general checking account started with \$22,751.25 and ended with \$23,223.19.

The SSTF also performed well in 2019. The SSTF mutual fund investments gained a total of \$5,814.27 in 2019, and the CD's gained \$672.73 this year. Darby noted that the investment strategy is working. Since the investment strategy began in 2014, the stock market index funds and CD's have yielded a profit of \$21,560.40.

In summary, the general accounts in 2019 started with a balance of \$22,751.25 and ended the year with \$23,223.19 for a gain of \$471.94. The SSTF accounts in 2019 started with a balance of \$114,895.94 and ended with \$120,710.24 for a gain of \$5,814.30. Detailed account balances and budgets for the Treasurer's Report can be found in Attachment 2.

#### **Finance Committee**

Eric Rahm presented the EXCOM approved 2020 budget (Attachment 3). The budget is similar to 2019, with a few exceptions. The CFM David Risberg Memorial Affiliate Grant was added to the income budget, which will be used to purchase t-shirts for upcoming disabled angler events. The expense line item for computer software was increased from \$500.00 in 2019 to \$970.00 in 2020 to account for the rising cost of computer software. Lastly, the A.S. Weithman Best Paper Award Contribution line item was raised from \$50.00 in 2019 to \$75.00 in 2020.

Jen Girondo presented the SSTF budget for 2020. The 2020 budget does not differ from the 2019 budget (Attachment 4).

Eric then asked if anyone has additional budget needs. Jeff Kopaska reported the Walleye Technical Group may be sending request for funding to each state chapter.

Eric then made a motion to approve the proposed 2020 MOAFS and Student Support budgets, which was seconded. The motion passed with all in favor.

#### **Award Presentation**

MOAFS and the Stream Team Program presented a letter of recognition to STU for helping enhance citizen efforts in protecting watersheds. STU Executive Director, Mary Culler, accepted the award.

MOAFS presented a letter of recognition to Dennis Keller for his leadership in the assessment, cleaning, and repairing of Missouri Department of Conservation (MDC) boat ramps after the 2019 flood. Dennis was present to accept the award.

Jen Girondo began by recognizing all student leaders that were present at the annual meeting.

#### **Past-President's Report**

Clint Hale began by sharing how much he enjoyed his MOAFS duties the past three years. Clint reminded everyone to attend the awards banquet following the annual meeting, where the Lee Redmond Citizen's Award, Stephen Weithman Award, and John L. Funk Award of Excellence would be presented.

#### **New Business**

Andy Turner asked membership if there was any new business to discuss; there was none. Andy proceeded to display the MOAFS work chart and pointed out several vacancies within committees. Andy encouraged people to join a committee and become more active in MOAFS. Lastly, Andy thanked all officers and committee members for their work throughout the year.

Andy then passed the gavel to incoming president Eric Rahm.

Eric's first order of business was to present Andy with a certificate of appreciation as outgoing President, and Darby Niswonger as outgoing Treasurer.

Eric then announced the MOAFS officer election results.

Eric thanked excom and committee members for their continued work with MOAFS, and also Jeff Kopaska for providing the NCD/AFS update.

Lastly, Eric encouraged membership to attend the membership appreciation event. The event will likely be held near Bennet Spring State Park in late summer or early fall. Activities include floating, fishing, games, and potluck/dinner.

A motion to adjourn the meeting was made and seconded. The motion passed all in favor. The meeting adjourned at 1714h.
